## REGULAR TOWN MEETING

January 16, 2018 – 7:30 p.m.

### Call to Order

*(Chair/President's Gavel—"Good evening/Welcome to the regular monthly Town Meeting for the Board of Town Commissioners for the Town of Upper Marlboro, January 16, 2018; May I have the Roll Call please?"*)

- Roll Call *(Clerk—reads off names for vocal response "present/here" from all Board members including self.)*
- Pledge of Allegiance *(President says— "Please rise for the Pledge of Allegiance")*
- Approval of the Agenda *(no vote necessary—just consent or propose edits)*  
*(President: "Do I have consent to the agenda?"*

### Announcements

- Election Results (Board Certification) *(Clerk— reads Certified results for the record)*  
*(President—"Does the Board accept the Election results and the qualifications of the candidates?" Commissioners should reply "Yea"*
- Board positions/Treasurer's Oath of Office *(President— recaps OM, asks Board for motion to nominate Linda as Treasurer, then President seconds the motion, President asks: "All in favor?" — then President administers the Oath.*

### Approval of Meeting Minutes & Financial Reports

*(President—asks Board if minutes were sufficiently reviewed, and if there are any changes.)*  
*In this case, you can say "the previous Board has informally approved of the Dec. 12 Regular Town Meeting and Dec. 19 Work Session minutes, and the new Board would like accept those findings and vote to approve both sets of minutes along with the Organizational Meeting minutes from January 15, 2018."*

*(President—asks Board: "Do I hear a motion to approve the meeting minutes from the Dec. 12 Regular Town Meeting, the Dec. 19 Work Session, and the Jan 15 Organizational Meeting?"*

*Commissioner #1: "I motion to approve all three sets of minutes"*

*Commissioner #2: "I second the motion"*

*President: "All in favor?"*

*C#1 and C#2 respond either "Yeah" or "Nay"; President vocalizes vote tally, and Clerk records.*

- Approval of the December 12, 2017 Regular Town Meeting minutes
- Approval of the December 19, 2017 Work Session minutes
- Approval of the Treasurer's Report, as of December 31, 2017.
